- Promote leadership integrity resonant with Corporate Social Responsibility (CSR)/Sustainability in the public and private sector
- Offer courses/seminars, accreditation, mentoring, coaching and research support in responsible leadership
- Provide high quality input and facilitation through founding members and key examples of responsible leadership through Associates
- Honour and publicise Fellowships
- Promote a charter on responsible leadership for companies and other organisations.

Individual IRL membership

- Annual membership of the IRL can be obtained at a specially reduced cost of £75 for those attending the launch (normally £100).
- It is designed to recognise a commitment by individuals to responsible leadership.
- Approval of members is based on completion of an application form and submission of a brief curriculum vitae.
- Membership includes the following benefits, amongst others:
 - The right to use the letters MIRL after the member's name
 - The opportunity to make approved postings on the IRL website
 - Reduced costs for workshops and other designated IRL events.

IRL organisational accreditation

- The IRL accreditation for organisations in the public and private sector aims to demonstrate responsible leadership.
- The IRL uses its expertise to assess organisations against an outcome-focused framework for a standard fee of £10k.
- The process consists of an IRL team visit to enable the completion of a self-assessment template, with supporting institutional documents.
- An additional visit then follows from the team to determine the outcome and recommendations, after a presentation and dialogue with organisational members and stakeholders.

Workshops and other events

- Regular workshops and other events will be organised by the IRL in London and other international locations, including at the UN headquarters in Geneva.
- The next event will be held in central London on the afternoon of Thursday 27 February entitled 'The case for responsible leadership' at a cost of £80 (£60 for members) including lunch and refreshments.
- Presentations will be made by Alex Mejia, Director of UNITAR, on the generic benefits of responsible leadership, and a team from Grant Thornton on corporate governance and company performance.
- Bespoke IRL courses, seminars and workshops will also be offered.
